#### REQUEST FOR COUNCIL ACTION

SUBJECT: APPROVAL OF PURCHASE ORDERS AND AGREEMENTS FOR VEHICLE MAINTENANCE AND REPAIR SERVICES EXCEEDING \$50,000 WITH CREST CHEVROLET AND JOHNSON CAT MACHINERY

### MOTION:

- 1. I move that the City Council approve a service agreement with Crest Chevrolet for the provision of vehicle maintenance and repair services in the amount of \$150,000 for a period of one (1) year with two (2), one (1) year options.
- 2. I move that the City Council approve a service agreement with Johnson Cat Machinery for the provision of specialty off-road, heavy equipment maintenance and repair services in the amount of \$200,000 for a period of one (1) year with two (2), one (1) year options.
- 3. I move that the City Council reject all bids received pertaining to categories: Solid Waste, Fire, On-Road Heavy, and Specialty Street Equipment from RFB 20121107.

### STAFF RECOMMENDATION:

Staff recommends the City Council approve a service agreement with Crest Chevrolet for the provision of vehicle maintenance and repair services for passenger, SUV light and super duty trucks in the amount of \$150,000 for a period of one (1) year with two (2), one (1) year options.

Staff recommends the City Council approve a service contract agreement with Johnson CAT Machinery for the provision of maintenance and repair service for specialty off-road equipment associated services in the amount of \$200,000 for a period of one (1) year with two (2), one (1) year options.

Staff recommends that the City Council reject the amended bid categories; Solid Waste, Fire, On-Road Heavy, and Specialty Street Equipment and direct staff to re-advertise and solicit bids with the amended changes.

### **DISCUSSION:**

The Equipment Maintenance Division maintains 396 vehicles throughout eight departments. Equipment Maintenance staff created eight vehicle categories for the 396 vehicles: passenger, SUV/Truck, Super Duty Trucks, Solid Waste Trucks, Fire

Equipment, On-Road Heavy Equipment, Specialty Street Equipment, and Off-Road Heavy Equipment.

QOL staff developed a scope of work and advertised a Request for Bid for maintenance, repairs and service for the eight categories. Staff received and analyzed the bids for compliance with the scope of specifications and four were identified as the lowest responsible bidders; Passenger, SUV/Truck, Super Duty, and Off-road Heavy. Vendor references were also checked by staff.
